#### PRIVACY NOTICE

#### **1** The Information We Collect & Process

a. We need to collect personal information about you to setup and administer your membership and may need to use it to contact you about it during the season to provide updates about training and matches and to advise when membership is due for renewal.

b. We would also like to contact you during the season to let you know about things that are going on at the club and to invite you to take part in club events, you can withdraw at any time.

c. All our public events are posted on our various Facebook group pages and twitter.

d. We won't sell your personal information to anyone.

e. We will keep the information you provide us on this membership form for the season it relates to and up until we have confirmed whether you wish to renew your membership or not, after which it will be archived and no longer processed other than for historic or statistical purposes.

#### 2 Your Rights to Data Privacy

a. Any individual whose personal data has been provided to us has a right to know what personal data we hold about them and how we are processing it, but we may charge a small fee for doing so.

b. If we have typed something in wrong you have the right to have any incorrect information we have recorded about you corrected.

c. If you think we're using your personal data in a way we shouldn't be you have the right to object to or restrict us processing your personal information.

d. If we asked for your consent to provide a specific service you have the right to withdraw your consent at any time and in such circumstance, we will stop processing your personal data in regard to these services.

e. If needed you have the right for any information you have supplied to us in this form that we are processing to be returned to you in a common computer file format such as excel.

f. If your membership is cancelled or lapses you have the right to request that information we hold about you is erased. We will review each request received to decide whether we are able to comply.

g. All we ask is that you put the request in writing and address to the Chairman of the club. We may need up to 28 days to stop what we have been doing.
